CHARGE: 501(c)—when shipped, the strength of the article of phenothiazine boluses differed from that which it purported or was represented to possess; 502(a)—the label statement "Phenothiazine 12.5 gms. [or "8 gms."] was false and misleading as applied to an article which contained substantially less than 12.5 grams [or "8 grams"] of phenothiazine per bolus; and the labeling of the article of Vetrodine contained false and misleading representations that the article was an adequate and effective treatment for controlling lumpy jaw and diseases of cattle associated with Actinomyces necrophorus infections of soft tissue found in lung and liver abscesses; and the labeling statement "The name is synonymous with Foot Rot and other iodine therapy" which implied that the article was effective wherever iodine therapy was indicated in animals, was false and misleading since it was contrary to fact.

Disposition: 7-18-60. Vetrochem, claimant, having consented to the entry of a decree without admitting the alleged adulteration or misbranding and the court having found that the articles were adulterated and misbranded as alleged, judgment of condemnation was entered and the *phenothiazine boluses* were ordered destroyed and the *Vetrodine* was ordered released under bond for relabeling.
