6401. (F.D.C. No. 42394. S. No. 2-460 P.)

INFORMATION FILED: 12-1-58, S. Dist. Fla, against Homer Thomas (who was operating Bobbie's Truck Stop, Oceanway, Fla.).

CHARGE: On 4-17-58, amphetamine sulfate tablets were dispensed once without a prescription.

PLEA: Guilty.

Disposition: 2-3-61. \$500 fine and probation for 3 years.

6402. (F.D.C. No. 42410. S. Nos. 2-868/70 P, 2-880 P, 2-887 P, 2-898/9 P.)

INFORMATION FILED: 2-12-59, S. Dist. Fla., against Welch's Truck Stop (a partnership), St. Johns County, Fla., and Claude Welch Whidby (partner).

CHARGE: Between 4-25-58 and 6-13-58, amphetamine sulfate tablets were dispensed 7 times without a prescription.

PLEA: Guilty.

Disposition: 2-24-61. Both defendants placed on probation for 3 years and individual fined \$500 also.

INFORMATION FILED: 11-3-59, S. Dist. Miss., against Jonathan P. Bilbo, t/a Clock Truck Stop, Picayune, Miss.

CHARGE: Between 9-12-58 and 12-17-58, amphetamine sulfate tablets were dispensed 11 times without a prescription.

PLEA: Guilty.

Disposition: 2-17-60. \$400 fine.

6404. (F.D.C. No. 44638. S. Nos. 46-410/3 P.)

INFORMATION FILED: 7-26-60, N. Dist. Miss., against Mrs. G. R. McCall, t/a A & M Truck Stop, Grenada, Miss., and Billy Wayne Robinson (employee).

CHARGE: Between 9-3-59 and 10-6-59, amphetamine sulfate tablets (counts 1 and 4) were dispensed twice, capsules containing a mixture of dextro-amphetamine sulfate and amphetamine sulfate (count 2) were dispensed once, and dextro-amphetamine sulfate tablets (count 3) were dispensed once without a prescription.

PLEA: Guilty by McCall to counts 1, 2, 3, and 4 and by Robinson to counts 1, 2, and 3.

Disposition: 12-9-60. McCall—\$400 fine and probation for 2 years; Robinson—probation for 2 years.

6405. (F.D.C. No. 44626. S. Nos. 80–361/6 P.)

INFORMATION FILED: 11-22-60, N. Dist. Ohio, against Arthur A. Figinsky, t/a Gaughn's Service Station, Columbiana, Ohio, and Samuel Petro (employee).

CHARGE: Between 9-10-59 and 9-30-59, amphetamine sulfate tablets were dispensed 6 times without a prescription.

PLEA: Guilty by Figinsky to all counts of the information and by Petro to counts 1, 5, and 6.

Disposition: 12-9-60. Figinsky—\$600 fine; Petro—\$300 fine.
