

PLEA: Nolo contendere by Yablon to counts 1, 7, 8, 9, 10, 11, and 12; guilty by Paul Lawrence and Pola Lawrence to counts 1, 2, 3, 4, 5, 6, 9, and 10.

DISPOSITION: 6-16-60. Yablon—\$700 fine, plus costs, and probation for 3 years; Paul Lawrence—probation for 2 years; Pola Lawrence—probation for 1 year.

6410. (F.D.C. No. 44346. S. Nos. 57-214 P, 57-220 P, 71-945 P, 72-308 P.)

INFORMATION FILED: 7-26-60, N. Dist. Fla., against Gilford L. Hill, and Grover Hamilton (employees of a truck stop at Grand Ridge, Fla.).

CHARGE: Between 10-9-59 and 10-27-59, *dextro-amphetamine sulfate tablets* (counts 1 and 2) were dispensed twice and *amphetamine sulfate tablets* (counts 3 and 4) were dispensed twice without a prescription.

PLEA: Guilty by Hill to all counts and by Hamilton to counts 3 and 4.

DISPOSITION: 12-14-60. Hill—4 years imprisonment; Hamilton—probation for 3 years.

6411. (F.D.C. No. 43720. S. Nos. 50-871 P, 50-873/4 P, 50-877 P.)

INFORMATION FILED: 6-29-60, W. Dist. Mich., against Nicholas S. Bander, t/a Banders Drug Store, Grand Rapids, Mich., and Henry L. Nibbelink (pharmacist).

CHARGE: Between 2-11-59 and 2-21-59, *dextro-amphetamine sulfate tablets* were dispensed 3 times (counts 1, 2, and 3) and *tablets containing amphetamine sulfate and phenobarbital* (count 4) were dispensed once without a prescription.

PLEA: Not guilty by Bander to all counts; and by Nibbelink to counts 1, 2, and 3.

DISPOSITION: On 9-12-60, the case against both defendants came on to trial before the court and a jury and, on 9-14-60, the jury returned a verdict of guilty against Nibbelink as to count 3 but was unable to agree on a verdict against either defendant as to the remaining counts.

On 10-12-60, Defendant Bander pleaded guilty to count 4 and was fined \$750. The remaining counts against him were dismissed.

Also on 10-12-60, Defendant Nibbelink was fined \$350 on count 3 and the remaining counts against him were dismissed.

6412. (F.D.C. No. 44279. S. Nos. 45-675/6 P.)

INFORMATION FILED: 12-15-60, N. Dist. Tex., against Houston Deford, t/a D & D Pharmacy No. 2, Amarillo, Tex., and Jerry Ammerman (pharmacist).

CHARGE: Between 2-14-59 and 3-3-59, *Dexedrine Sulfate tablets* were dispensed twice upon requests for prescription refills without authorization by the prescriber.

PLEA: Guilty by Deford and Ammerman to dispensing the tablets one time each.

DISPOSITION: 2-21-61. \$500 fine against Deford and \$100 fine against Ammerman.

6413. (F.D.C. No. 43694. S. Nos. 56-591 P, 56-605 P, 56-609 P, 71-788 P.)

INFORMATION FILED: 12-3-59, S. Dist. Fla., against John M. Carter, (a partner in the partnership of Carter's Pharmacy), Sarasota, Fla., and Clinton P. Smith (pharmacist).

CHARGE: Between 5-4-59 and 6-8-59, *Dexedrine Sulfate tablets* were dispensed once and *Seconal Sodium capsules* were dispensed 3 times upon requests for prescription refills without authorization from the prescriber.

PLEA: Nolo contendere by Carter to dispensing the *Dexedrine Sulfate tablets* and the *Seconal Sodium capsules* once each and by Smith to dispensing the *Seconal Sodium capsules* twice.

DISPOSITION: 1-16-61. \$100 fine for each defendant, plus costs.

6414. (F.D.C. No. 44275. S. Nos. 5-392/4 P.)

INFORMATION FILED: 3-8-60, E. Dist. Va., against Josiah W. Chamblee, t/a **Stuart Circle Pharmacy, Richmond, Va., and Forrest E. Parker (pharmacist).**

CHARGE: Between 6-23-59 and 7-1-59, *Dexedrine Sulfate tablets* were dispensed twice and *Seconal Sodium capsules* were dispensed once upon requests for prescription refills without authorization by the prescribers.

PLEA: Guilty.

DISPOSITION: 3-1-61. Josiah Chamblee was fined \$100 for dispensing the *Dexedrine Sulfate tablets* once and Forrest Parker was fined \$200, of which \$100 was suspended, with respect to dispensing *Dexedrine Sulfate tablets* once and the *Seconal Sodium capsules* once.

6415. (F.D.C. No. 44337. S. Nos. 4-294 P, 5-711 P, 5-713 P, 5-717/20 P.)

INFORMATION FILED: 6-9-60, E. Dist. Va., against Meyer H. Salsbury, t/a **Chamberlayne Avenue Pharmacy, Richmond, Va.**

CHARGE: Between 6-13-59 and 7-6-59, *Dexedrine Sulfate tablets* were dispensed 3 times, *phenobarbital tablets* were dispensed twice, and *Equanil tablets* were dispensed once upon requests for prescription refills without authorization from the prescriber, and *Pentids tablets* were dispensed once without a prescription.

PLEA: Not guilty.

DISPOSITION: On 11-16-60, the case came on for trial before the court and a jury. On 11-17-60, the jury returned a verdict of guilty. Thereafter, on 12-2-60, the defendant was fined \$1,750 and sentenced to 1 year in prison on each of 7 counts, the prison sentences to run concurrently. Imposition of the prison sentence was suspended, except for 2 weeks to be served and defendant was placed on probation for 3 years beginning after the service of 2 weeks imprisonment.

6416. (F.D.C. No. 44312. S. No. 61-581 P.)

INFORMATION FILED: 9-14-60, E. Dist. Mich., against **Alexander's Pharmacy, Inc., Detroit, Mich., and Alex Pasquinzo (president).**

CHARGE: On 4-20-59, *Doriden tablets* were dispensed once without a prescription.

PLEA: Guilty.

DISPOSITION: 12-5-60. Each defendant fined \$250.

6417. (F.D.C. No. 44640. S. Nos. 73-709/10 P.)

INFORMATION FILED: 8-25-60, N. Dist. Miss., against **John Seth Anderson, t/a Anderson's Truck Stop, Grenada, Miss.**

CHARGE: On 10-7-59, *desoxyephedrine hydrochloride tablets* were dispensed twice without a prescription.
