

6511. (F.D.C. No. 44955. S. Nos. 72-333/6 P.)

INFORMATION FILED: 3-30-61, E. Dist. S.C., against **Elton Joseph Miller, t/a Lucky's Truck Stop, Yemassee, S.C.**

CHARGE: On 12-13-59, *amphetamine sulfate tablets, dextro-amphetamine sulfate tablets, and desoxyephedrine hydrochloride tablets* were each dispensed once without a prescription.

PLEA: Guilty.

DISPOSITION: 5-23-61. Defendant given a sentence of 2½ years in prison.

6512. (F.D.C. No. 44952. S. No. 46-557 P.)

INFORMATION FILED: 12-29-60, M. Dist. Ala., against **John Billy Hill, formerly t/a Chisholm's Drug Store, Montgomery, Ala.**

CHARGE: On 10-14-59, *amphetamine sulfate tablets* were dispensed once without a prescription.

PLEA: Guilty.

DISPOSITION: 6-15-61. Sentence of 90 days in jail, and probation for 3 years.

6513. (F.D.C. No. 44629. S. Nos. 59-535/6 P.)

INFORMATION FILED: 7-26-60, E. Dist. N.C., against **Julius G. Moore, t/a Hilton Truck Stop, Wilmington, N.C.**

CHARGE: Between 6-11-59 and 6-24-59, *amphetamine sulfate tablets* were dispensed twice without a prescription.

PLEA: Not guilty.

DISPOSITION: The case was tried by the court without a jury and on 6-22-61, the defendant was found guilty. On 6-23-61, Moore was fined \$200, the imposition of prison sentence was suspended, and 2 years probation was imposed upon the special condition that the fine be paid in 6 months and that the court-appointed attorney be paid \$200 within 3 months.

INFORMATION FILED: 3-15-61, M. Dist. Ga., against **Albert Edward Rocke, t/a Blue Diamond Cafe, Perry, Ga.**

CHARGE: On 2-23-61, *dextro-amphetamine sulfate tablets* were dispensed twice without a prescription.

PLEA: Guilty.

DISPOSITION: 4-21-61. \$1,000 fine and probation for 3 years.

INFORMATION FILED: On or about 2-13-61, M. Dist. Ala., against **Ernest Bradford Donahoo, t/a Brad & Lorene Donahoo's Truck Stop, Prattville, Ala.**

CHARGE: On 10-12-59, *dextro-amphetamine sulfate tablets* were dispensed once without a prescription.

PLEA: Guilty.

DISPOSITION: 4-21-61. Sentence of 3 months in jail.

6516. (F.D.C. No. 44965. S. Nos. 46-536 P, 46-542 P.)

INFORMATION FILED: 2-13-61, M. Dist. Ala., against **Kenneth J. Bragg, t/a Kent Bragg Service Station, Phenix City, Ala., and Garland W. Knight (employee).**

CHARGE: Between 9-1-59 and 9-8-59, *dextro-amphetamine sulfate tablets* (counts 1 and 2) were dispensed twice without a prescription.
