

PLEA: Guilty by Bragg to count 1 and by Knight to count 2.

DISPOSITION: 4-21-61. Bragg—\$1,000 fine; Knight—3 years probation.

6517. (F.D.C. No. 45227. S. No. 73-598 P.)

INFORMATION FILED: 2-14-61, M. Dist. Ala., against **King Super Drugs, Inc., Dothan, Ala., and William Mintz (secretary-treasurer, manager, and pharmacist for the corporation).**

CHARGE: On 9-10-59, *dextro-amphetamine sulfate tablets* were dispensed once without a prescription.

PLEA: Guilty.

DISPOSITION: 5-16-61. Corporation fined \$1,000; individual given a sentence of 1 year in jail, of which he was to serve 6 months with the balance of the sentence being suspended and the individual being placed on probation for 3 years, such probation to begin after serving the 6 months jail sentence.

6518. (F.D.C. No. 45553. S. Nos. 3-332 R, 5-865 R.)

INFORMATION FILED: 3-7-61, E. Dist. N.C., against **Jim H. Turnage, t/a Big Jim's Service Station, Goldsboro, N.C.**

CHARGE: On 12-13-60, *dextro-amphetamine sulfate capsules* were dispensed twice without a prescription.

PLEA: Guilty.

DISPOSITION: 5-22-61. 6-month prison sentence suspended, and probation for 2 years to run concurrently with probation issued in the case reported in drug and device notice of judgment, No. 6536.

6519. (F.D.C. No. 44662. S. Nos. 85-112 P, 85-563/4 P, 85-572/3 P.)

INFORMATION FILED: 5-24-61, S. Dist. N.Y., against **Sol's Pharmacy (a partnership), Bronx, N.Y., and Sol Dresdner and Harry Dresdner (partners).**

CHARGE: Between 10-26-59 and 11-24-59, *dextro-amphetamine sulfate tablets* were dispensed once and *Miltown tablets* were dispensed twice without a prescription, and *Seconal Sodium capsules* were dispensed twice by refilling a prescription without obtaining authorization from the prescriber.

PLEA: Guilty by the partnership and Sol Dresdner to 5 counts of the information; and by Harry Dresdner to 2 counts of the information.

DISPOSITION: 7-28-61. Partnership fined \$250; each individual fined \$50.

6520. (F.D.C. No. 43688. S. Nos. 44-522 P, 44-540 P, 44-546 P, 44-661 P, 44-665 P, 56-385 P.)

INFORMATION FILED: 1-26-60, W. Dist. N.C., against **Charlotte Drug Co. (a partnership), Charlotte, N.C., Sidney Schenck (a partner in the partnership), and Robert Frank Holland (an employee of the partnership).**

CHARGE: Between 12-9-58 and 1-30-59, *Dexedrine Sulfate tablets* (counts 1, 2, 3, and 5) were dispensed 4 times, *Dexamyl tablets* (count 4) and *secobarbital sodium capsules* (count 6) were each dispensed once upon requests for prescription refills without authorization from the prescriber.

PLEA: Not guilty by Charlotte Drug Co. to all counts of the information; by Sidney Schenck to count 1; and by Robert Frank Holland to counts 2 to 6 inclusive.

DISPOSITION: The case came on for trial before the court without a jury on 10-25-60, and at its conclusion, Charlotte Drug Co. and Robert Frank Holland
