On 4-5-61, the court fined the company \$750 and Holland \$350 on counts 1, 2, and 3, and continued the prayer for judgment against such defendants on counts 4, 5, and 6 for 3 years on condition that Holland should not be employed by the company.

INFORMATION FILED: 10-15-59, W. Dist. N.C., against Elbert P. Phillips, t/a Queen City Pharmacy, Charlotte, N.C., and Lemuel A. Yancey (pharmacist).

CHARGE: Between 6-30-58 and 9-18-58, *Dexedrine Sulfate tablets* were dispensed 4 times (counts 2, 5, 7, and 8), *Nembutal Sodium capsules* were dispensed 4 times (counts 3, 4, 6, and 9), and *Seconal Sodium capsules* were dispensed twice (counts 1 and 10) upon requests for prescription refills without authorization from a prescriber.

PLEA: Not guilty to all counts by Phillips; nolo contendere to counts 1 to 5 inclusive by Yancey.

DISPOSITION: The case against Phillips came on for trial before the court and jury and, on 10-6-60, the jury returned a verdict of guilty. On 4-7-61, Phillips was fined \$750 and Yancey \$350.

INFORMATION FILED: 12-2-59, S. Dist. Fla., against Jacob C. Bell, t/a Bell Drugs, Jacksonville, Fla.

CHARGE: Between 11-24-58 and 2-11-59, *Dexedrine Sulfate tablets* were dispensed 3 times, *amphetamine sulfate tablets* were dispensed 4 times, and *Nembutal Sodium capsules* and *pentobarbital sodium capsules* were each dispensed once, upon requests for prescription refills without authorization from a prescriber.

PLEA: Not guilty.

DISPOSITION: On 2-13-61, the case came on for trial before the judge and jury and, on 2-14-61, the jury returned a verdict of not guilty on all counts.

INFORMATION FILED: 12-15-60, N. Dist. Tex., against Glenn Miller, t/a San Jacinto Drug, Amarillo, Tex.

CHARGE: On 3-11-59, *Dexedrine Sulfate tablets* were dispensed once upon request for a prescription refill without obtaining authorization by the prescriber.

PLEA: Guilty.

DISPOSITION: 2-21-61. \$400 fine.

CHARGE: Between 7-17-59 and 5-18-60, *Dexedrine Sulfate tablets* (counts 1 and 2) were dispensed twice and *Miltown tablets* (counts 3, 4, 5, 6, 7, and 8) were dispensed 6 times, upon requests for prescription refills without authorization by the prescriber.
