

PLEA: Guilty by Turner to all counts; by Wager to counts 1, 2, 3, and 7.

DISPOSITION: 6-30-61. Turner was fined \$400 and Wager \$200.

6525. (F.D.C. No. 45216. S. Nos. 44-471 P, 44-803/4 P, 56-780 P, 72-101/4 P.)

INFORMATION FILED: 8-18-61, N. Dist. Ga., against Edsel Kerns Gladden (pharmacist), Decatur, Ga.

CHARGE: Between 5-15-59 and 9-18-59, *Dexedrine Sulfate tablets* were dispensed 5 times, *Seconal Sodium capsules* were dispensed twice, and *Equanil tablets* were dispensed once, upon requests for prescription refills without authorization from the prescriber.

PLEA: Guilty.

DISPOSITION: 9-14-61. Placed on probation for 2 years.

6526. (F.D.C. No. 44953. S. No. 46-602 P.)

INFORMATION FILED: 1-3-61, N. Dist. Ala., against Sam K. Mickwee, t/a Fultondale Sundries, Fultondale, Ala.

CHARGE: On 10-23-59, *desoxyephedrine hydrochloride tablets* were dispensed once without a prescription.

PLEA: Guilty.

DISPOSITION: 7-31-61. \$500 fine and probation for 3 years.

6527. (F.D.C. No. 45203. S. Nos. 46-532 P, 46-539 P, 46-545 P, 74-023 P, 74-031 P.)

INFORMATION FILED: 2-13-61, N. Dist. Ala., against Robert Ray Dunn and William A. Timmerman (co-partners of a truck stop), Locust Fork, Ala.

CHARGE: Between 8-13-59 and 9-11-59, *desoxyephedrine hydrochloride tablets* (counts 1, 2, and 4) were dispensed 3 times, and *amphetamine sulfate tablets* (counts 3 and 5) were dispensed twice, without a prescription.

PLEA: Guilty by Dunn to count 1; by Timmerman to counts 2, 3, 4, and 5.

DISPOSITION: 7-31-61. Dunn and Timmerman were fined \$250 each.

6528. (F.D.C. No. 44958. S. Nos. 57-223 P, 57-226 P, 72-508 P, 72-521 P, 72-529 P, 72-544 P, 72-546 P, 72-552 P, 72-564 P.)

INFORMATION FILED: 3-2-61, S. Dist. Ga., against James C. Thaggard, Jr., t/a Thaggard's Pharmacy, Savannah, Ga.

CHARGE: Between 10-21-59 and 1-13-60, *secobarbital sodium capsules* were dispensed 6 times, and *amphetamine sulfate tablets* were dispensed 3 times upon requests for prescription refills without authorization by the prescriber.

PLEA: Nolo contendere.

DISPOSITION: 3-27-61. Fine of \$750 and probation for 5 years.

6529. (F.D.C. No. 44351. S. Nos. 59-442/7 P.)

INFORMATION FILED: 6-29-60, E. Dist. N.C., against Walter R. Lane, t/a Lane's Brooklyn Pharmacy, Wilmington, N.C.

CHARGE: Between 4-23-59 and 6-11-59, *secobarbital sodium capsules* and *Equanil tablets* were each dispensed 3 times without a prescription.

PLEA: Guilty.

DISPOSITION: 4-24-61. \$500 fine and probation for 2 years.
