

6530. (F.D.C. No. 44932. S. Nos. 56-827 P, 56-835 P, 71-829 P, 71-837 P, 72-152 P.)

INFORMATION FILED: 11-15-60, S. Dist. Fla., against **Joseph Jason Stafford, Jr., and Edmund Brooks Warren (pharmacists), Sarasota, Fla.**

CHARGE: Between 9-14-59 and 10-19-59, *Seconal Sodium capsules* (counts 1, 2, and 3) were dispensed 3 times, and *Tuinal capsules* (counts 4 and 5) were dispensed twice upon requests for prescription refills without authorization by the prescriber.

PLEA: Nolo contendere by Stafford to 5 counts of the information; and by Warren to counts 2, 3, and 4.

DISPOSITION: 1-16-61. Each defendant fined \$100, plus costs.

6531. (F.D.C. No. 43674. S. No. 46-098 P.)

INFORMATION FILED: 11-25-60, S. Dist. Tex., against **Merl L. Gamble (a pharmacist for a drug store at Donna, Tex.).**

CHARGE: On 2-18-59, *penicillin G potassium tablets* were dispensed once without a prescription.

PLEA: Guilty.

DISPOSITION: 4-14-61. The defendant was given a sentence of 6 months in jail, which was suspended.

6532. (F.D.C. No. 43266. S. Nos. 47-941 P, 47-945/9 P, 47-962/3 P, 47-965 P, 47-980 P, 48-161/2 P.)

INFORMATION FILED: 12-4-59, Dist. Mass., against **John E. Carroll, t/a Hailer's Drug Store, Roslindale (Boston), Mass.**

CHARGE: Between 1-30-59 and 3-11-59, *pentobarbital sodium capsules* were dispensed 5 times upon requests for prescription refills without authorization by the prescriber, and *amphetamine sulfate tablets* were dispensed twice, *pentobarbital sodium capsules* were dispensed twice, and *Tuinal capsules* were dispensed 4 times without prescriptions.

PLEA: Not guilty.

DISPOSITION: The case came on for trial before the court and jury on 3-20-61, and was concluded on 3-22-61, with the return by the jury of a verdict of not guilty.

6533. (F.D.C. No. 44298. S. Nos. 46-222 P, 46-226/7 P, 46-229 P.)

INFORMATION FILED: 1-3-61, S. Dist. Tex., against **Clea D. Butler, t/a Butler's Pharmacy, South Houston, Tex., and Laverna Lakey and James B. Smith (pharmacists).**

CHARGE: Between 4-25-59 and 5-27-59, *Decadron tablets* were dispensed twice and *Chloromycetin capsules* were dispensed twice upon requests for prescription refills without authorization by the prescribers.

PLEA: Guilty by Clea Butler to dispensing *Chloromycetin capsules* once; by James Smith to dispensing *Decadron tablets* once; and by Laverna Lakey to dispensing both drugs one time each.

DISPOSITION: 3-3-61. Clea Butler was fined \$500 and was given a sentence of 6 months in jail, which sentence was suspended for 3 years; James Smith and Laverna Lakey were each fined \$100 and given a sentence of 60 days in jail, which sentence was suspended for 2 years.
