

4000. Misbranding of mustard and bran. U. S. v. 24 Cases of Mustard and Bran.
Default decree of condemnation. Product ordered distributed for chari-
table purposes. (F. D. C. No. 7610. Sample No. 79688-E.)

On June 16, 1942, the United States attorney for the Eastern District of Kentucky filed a libel against 24 cases of mustard and bran at Middlesboro, Ky., alleging that the article had been shipped in interstate commerce on or about March 16, 1942, by Dee's Foods, Inc., from Bristol, Va., and Bristol, Tenn.; and charging that it was misbranded.

The article was alleged to be misbranded in that the statement on the jars "Contents 2 Pounds Dee's Energized Mustard & Bran" was false and misleading, since the jars contained less than 2 pounds. It was alleged to be misbranded further in that it was in package form and failed to bear a label containing an accurate statement of the quantity of the contents.

On July 9, 1942, no claimant having appeared, judgment of condemnation was entered and the product was ordered distributed for charitable purposes.
