

**CEREALS AND CEREAL PRODUCTS****BAKERY PRODUCTS\***

**15107. Adulteration of pies.** U. S. v. Meacham's Bakery, a partnership, Charles T. Meacham, Robert J. Swisher, and Walter C. Meacham. Pleas of guilty. Partnership fined \$200 and each individual defendant fined \$10, together with costs. (F. D. C. No. 26802. Sample Nos. 45516-K, 45518-K.)

**INFORMATION FILED:** June 10, 1949, Northern District of Iowa, against Meacham's Bakery, Sioux City, Iowa, Charles T. Meacham and Robert J. Swisher, partners, and Walter C. Meacham, an employee.

**ALLEGED SHIPMENT:** On or about December 6, 1948, from the State of Iowa into the State of Nebraska.

**LABEL, IN PART:** "Meacham's Apple [or "Cherry"] Pie."

**NATURE OF CHARGE:** Adulteration, Section 402 (a) (3), the products consisted in part of filthy substances by reason of the presence of insect fragments and rodent hair fragments; and, Section 402 (a) (4), they had been prepared and packed under insanitary conditions whereby they may have become contaminated with filth.

**DISPOSITION:** July 21, 1949. Pleas of guilty having been entered, the partnership was fined \$200 and each individual defendant was fined \$10, plus costs.

**15108. Adulteration of Fritos (corn product).** U. S. v. William Peche (So Good Potato Chip Co.). Plea of nolo contendere. Fine, \$250. (F. D. C. No. 26801. Sample Nos. 45741-K, 57442-K.)

**INFORMATION FILED:** May 26, 1949, Eastern District of Missouri, against William Peche, an individual, trading as the So Good Potato Chip Co., at St. Louis, Mo.

**ALLEGED SHIPMENT:** On or about January 10, 1949, from the State of Missouri into the State of Illinois.

**LABEL, IN PART:** "So Good Fritos."

**NATURE OF CHARGE:** Adulteration, Section 402 (a) (3), the product consisted in part of a filthy substance by reason of the presence of insect fragments and rodent hair fragments.

**DISPOSITION:** September 27, 1949. A plea of nolo contendere having been entered, the defendant was fined \$250.

**FLOUR**

**15109. Adulteration of whole wheat flour and bread.** U. S. v. Cross Baking Co., Inc. Plea of guilty. Fine of \$600 and costs. (F. D. C. No. 26807. Sample Nos. 5788-K, 5791-K, 5792-K.)

**INFORMATION FILED:** July 21, 1949, District of Vermont, against Cross Baking Co., Inc., Montpelier, Vt.

**ALLEGED VIOLATION:** On or about November 27, 1948, the defendant received at Montpelier, Vt., a number of bags of flour which had been shipped from the State of New York. While the flour was held for sale after shipment in interstate commerce, the defendant caused a number of bags of the flour to be placed in a building that was accessible to rodents; and as a result, the flour
